Healthcare-related businesses and government agencies are joining the effort by providing convenient, secure collection receptacles expressly for the safe disposal of pharmaceutical-controlled substances as specified by the U.S. Drug Enforcement Administration (DEA).

The **MEDDROP** collection system provides a simple and effortless way for individuals to safely dispose of unused or expired medications. It is also an easy-to-manage program for DEA-registered collectors, such as for pharmacies and law enforcement agencies.

What Can Be Accepted?

YES

All expired, unused or unwanted controlled, non-controlled, and over the counter medications, including pet medications. Liquid products, such as cough syrup, must be tightly capped.

NO

Trash, Regulated Medical Waste, Sharps, Syringes, Thermometers, Hazardous Waste, Aerosols, Illicit Drugs or Commercial Waste.

How **MEDDROP** Works

The **MEDDROP** kiosk ships to your facility with two collection bundles, including liners and supplies to easily install and return collected contents via UPS.

The delivery of collection bundles can be scheduled to meet a customer's specific needs with shipping both ways always included. Additional bundles can be ordered with a phone call or email.

Installing and returning liners is easy:

- Form the box and tape bottom
- Insert liner in and around box
- Place inside collection unit
- Check the fill level at least weekly or as observed activity dictates
- When full, simply cinch and apply seal to the inner liner, complete and enclose shipping document, tape the box closed, affix the prepaid shipping label, and contact UPS for pick up.

All returned contents are witness-destroyed by incineration, ensuring that the pharmaceuticals are non-retrievable and environmentally harmless.

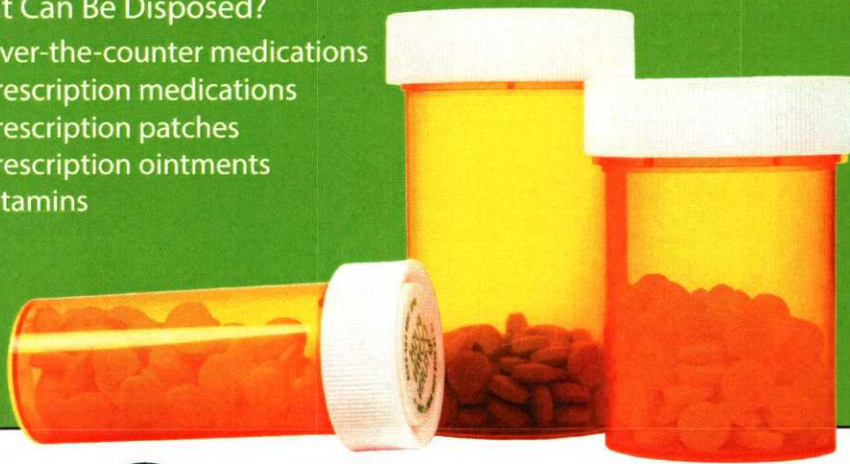

- Over-the-counter medications
- Prescription medications
- Prescription patches
- Prescription ointments
- Vitamins



Only Schedule II-V controlled substances and non-controlled substances permitted. Schedule I controlled substances that are not lawfully possessed by the ultimate user and other illicit or dangerous substances are not permitted. Regulated Medical Waste including Sharps and Hazardous Waste are not permitted
